

# FightFi Claim Terms and Conditions

**Effective Date:** 1/17/2025

Welcome to FightFi! These Terms and Conditions ("Terms") govern your access to and use of the FightFi Fight.ID Claim website ("Website") and its associated services ("Services"). By accessing or using the Website, you agree to these Terms. If you do not agree, please refrain from using the Website.

FightFi is not being offered by Zuffa International, LLC ("Zuffa"), nor by any of Zuffa's parents, subsidiaries or affiliates.

## 1. Eligibility

1.1. **User Eligibility:** You must be at least 18 years old or the age of majority in your jurisdiction to use this Website. By accessing or using the Website, you represent that you are over 18 years of age, or over the age of majority in the jurisdiction of your residency, and that the access and use of the Website and Services is legal in the jurisdiction of your residency.

1.2. **Conditional Access:** FightFi is being made available on the Terms contained herein and/or any updates to these Terms.

2.1. **Claim Eligibility:** Fight.IDs are available to all UFC Strike Users, and users who hold eligible digital assets in a connected wallet ("**Eligible Assets**").

2.2. **How to Claim:** To claim your Fight.ID, connect your wallet and follow the instructions provided to verify your ownership of the Eligible Assets. You may be required to provide accurate personal and account information.

2.3. **User Responsibility:** You are responsible for safeguarding your Fight.ID credentials and ensuring their proper use. FightFi is not responsible for any unauthorized access to your Fight.ID, nor does FightFi have any obligation to replace a lost digital asset.

**2.4. No Guarantees:** Claiming a Fight.ID does not guarantee eligibility for future rewards, benefits, or other digital assets. The Website and Services offered may be terminated at any time, with or without notice to users.

The Website and Services are being offered solely for entertainment purposes. By accessing and using the Website, you represent and agree that you are using the Services solely for entertainment purposes, that the rewards, benefits or other digital assets provided pursuant hereto are not securities of any type (as defined by your jurisdiction of residency), and that you are not accessing or using the Website for investment or any purpose other than entertainment.

**4.2. Data Usage:** All data collected, if any, will only be used for the purpose of operating the FightFi ecosystem, including creating and maintaining your Fight.ID.

### **5. Dispute Resolution**

5.1. **Informal Resolution:** In the event of a dispute, you agree to first attempt to resolve the issue informally by contacting FightFi support.

5.2. **Binding Arbitration:** If any informal resolution of a dispute, claim or controversy fails after a period of 60 days from the date you first attempt to resolve such dispute, claim or controversy informally, such dispute, claim or controversy will be resolved through binding arbitration under the rules of the American Arbitration Association (AAA) in San Francisco, California, United States of America pursuant to AAA's commercial rules. The arbitrability of such dispute, claim or controversy shall likewise be determined in such arbitration and exclusively by the arbitrator, and it is the intention of the parties that their agreement that the arbitrator determine arbitrability be deemed "clear and unmistakable" by any court enforcing this provision.

5.3. **Governing Law:** These Terms are governed by the laws of the State of California, without regard to conflict-of-law principles. You agree to submit to the personal jurisdiction of the courts in the State of California for the purpose of the recognition or enforcement of any arbitral award.

5.4. **Jurisdiction:** Any legal action related to these Terms shall be brought in the courts located in California.

6.1. **Changes to Terms:** FightFi reserves the right to modify these Terms at any time. Changes will be effective upon posting to the Website. Continued use of the Website and access to the Services constitutes acceptance of the updated Terms.
